LTA-ORDER-0006-11-21-12

PURSUANT TO ARTICLE IV SECTION 20 OF THE LIBERIA TELECOMMUNICATIONS ACT OF 2007, THE LIBERIA TELECOMMUNICATIONS AUTHORITY HEREBY ISSUES AND PUBLISHES THE FOLLOWING ORDER OF SUSPENSION:

- The two (2) operating Licenses of Lonestar Communications Corporation d/b/a Lonestar Cell/MTN are suspended for three (3) days from 12:01AM on the 3rd day of December 2012 through 12 Midnight on the 5th day of December 2012 ("Suspension Period");
- For the purposes of this Order, Suspension means that Lonestar Cell/MTN customers will be able to receive calls but will not be able to make calls for the duration of the Suspension Period ("No Calls Provision");
- To minimize the impact of this Order of Suspension on customers in areas in which only Lonestar Cell/MTN provides services, said areas are exempted from the No Calls Provision, such that those customers will be allowed to receive and make calls. However, Lonestar Cell/MTN shall pay 25% of the revenues generated from such operations into the Government of Liberia Consolidated Fund at the Ministry of Finance;
- Lonestar Cell/MTN shall take the requisite steps to ensure that Emergency Numbers for Police (Military and Para-Military), Fire and Ambulance services can be activated by customers, even though they are not otherwise able to call out;
- To facilitate a financial audit of the revenues Lonestar Cell/MTN is required to turn over to the GoL pursuant to this Order, Lonestar Cell/MTN shall identify and isolate Call Detail Records (CDRs) and Billing Detail Records at the Base Terminal Station (BTS) level, as determined in consultation with the LTA Engineering Department.
- Within 48 hours following the issuance of this Order, Lonestar Cell/MTN shall commence the process of timely and aggressively conducting public awareness

campaigns through text messaging, print and broadcast media, and other public information conduits, to inform all of its subscribers about, and to adequately prepare them for, the effects of the Suspension of Lonestar Cell/MTN's two (2) operating Licenses, and the planned implementation process for this Suspension;


- Lonestar Cell/MTN shall work with the Engineering Department and the Public & Consumer Affairs Department of the LTA, to ensure a smooth implementation of this Order of Suspension.

THIS ORDER OF SUSPENSION SHALL TAKE IMMEDIATE EFFECT. UPON PUBLICATION, IT SHALL HAVE THE SAME LEGAL FORCE AS A RULE OF THE LTA AND SHALL REMAIN IN FULL FORCE AND EFFECT UNLESS / UNTIL OTHERWISE ORDERED BY THE LTA OR PURSUANT TO LEGAL PROCESS.




