



**LTA-ORDER: 0021-02-04-2026**

**SUSPENSION ORDER OF STARCELL INTERNATIONAL LIBERIA UNIVERSAL TELECOMMUNICATIONS LICENSE AND SPECTRUM AUTHORIZATION (LTA-UTL/STARCELL INTL COMPANY-03202020-001)**

PURSUANT TO ARTICLE IV SECTION 20 OF THE TELECOMMUNICATIONS ACT OF 2007, THE LIBERIA TELECOMMUNICATIONS AUTHORITY HEREBY ISSUES AND PUBLISHES THIS ORDER OF SUSPENSION:

- I. That the Operating License and Spectrum Authorization of Starcell International Liberia are hereby suspended for a period of ninety (90) days or three (3) months commencing at **12:01 am on the 9 February 2026 and ending at 12 midnight on the 10 May 2026 ("Suspension Period")**;
- II. That the reasons for this Order of Suspension are:
  - a. Starcell International's failure to provide comments on the LTA's proposed revocation letter dated September 16, 2025, which gave Starcell International thirty (30) days to respond;
  - b. Starcell International's failure to start operations in Liberia many years after the issuance of its License;
  - c. Starcell International failed to satisfy its financial obligations to the Government of Liberia through the Liberia Revenue Authority (LRA) and the Liberia Telecommunications Authority (LTA) as stipulated in Starcell International's License;
  - d. Starcell International failed to comply with the LTA's Regulations and other related Acts of Government;
- III. That the foregoing reasons constitute a material Breach of the License and Spectrum Authorization conditions of Starcell, which therefore warrants this Order of Suspension.

IV. That during the Suspension Period, Starcell International shall:

- a. Launch operations in Liberia,
- b. Satisfy its financial obligations to the Government through the LTA,
- c. Comply with LTA's existing Regulations;


V. That in the event of Starcell International's failure to remedy the breach during the Suspension Period, the LTA shall revoke the License and Spectrum Authorization heretofore issued to Starcell International Liberia with immediate effect.




